2) PROPOSED NEW ARTS AND CULTURE COMMISSION WORK PLA, CONVENING, ANDCULTURAL INVENTORY REVIEW AND DISCUSS PROPOSED ITEMS

Arts and Culture Management Consultant, Karen Constine celebrated the milestones working towards the creation of the new Arts and Culture Commission She also led a discussion regarding the roles and responsibilities of the commission, the council liaison steering commission, the stake holders and other interested parties. The liaisons decided that all events that had been conducted in the past by Recreation and Parks Commission would be grandfathered under this commission's purvey, and all future events, regardless of their venue, would fall under the Arts and Culture Commission purvey. Two representatives of City Council, two of Arts and Culture, two of Recreation and parks and two of Cultural Heritage will form the standing steering committee for Cultural Arts. In addition, there will be a biannual Arts and Culture Town Hall Meeting open to all residents and arts organizations in the City to provide feedback. A monthly stakeholder meeting to initiate events, collaborate and partner for arts and culture events in the City will be established to take place in monthly basis. The order of process for the Arts and Culture will require the stakeholder committee to discuss and recommend initiatives, the Arts and Culture Commission to review and weigh in the recommended initiatives and finally City Council to review for final approval the proposed initiatives. There would also be ad hoc committees to focus on specific topics such as communications, public partnerships and special events, tec. that will meet in addition to the monthly stakeholder meetings. The Liaisons expressed the importance to bring the resulting partnership events to the City of

Beverly Hills and to promote local artists and venues through the Arts and Culture events.
There was a prolific discussion of potential arts and culture initiatives.
